## BRYANT GARDENS SETTLES REAL ESTATE TAX PROTEST AND RECEIVES REFUND

Bryant Gardens has settled a Real Estate Tax Certiorari Protest with the City of White Plains.

A Real Estate Tax Certiorari Protest is the process whereby a property owner, such as Bryant Gardens Corp., legally challenges the real estate tax assessment on its property.

The Bryant Gardens real estate tax challenge was initiated in the early 1990s. The successful settlement has resulted in a real estate tax refund to Bryant Gardens Corp. in the amount of \$239,322. This money has been deposited to the Bryant Gardens Corp. Reserve Fund.

Going forward, the settlement will provide a financial benefit to Bryant Gardens Corp. Since the tax assessment has been reduced, Bryant Gardens Corp. will be able to project a lower real estate tax expense in the 2010 operating budget.

This is great financial news for Bryant Gardens, and it could not come at a better time.

The Board of Directors would like to take this opportunity to thank and congratulate Michael Pearl, our attorney, who was instrumental in achieving this settlement.

#### CHANGE IN CORPORATE TAX YEAR

The Bryant Gardens Corp. Board of Directors has approved a change in their corporate financial reporting period from a fiscal year, which ran from September 1 to August 31 to a calendar year which will begin January 1.

The Board and Management believe that it is in the best interest of Bryant Gardens Corp. to operate on a calendar year.

A big advantage is that the Bryant Gardens budget would be adopted in November, instead of July. In November, the Board should be able to forecast heating oil prices more accurately since the heating season will already have begun. Other major financial expenses, such as Insurance, can also be more accurately forecast. Since the Corporation's Insurance Policy renews on December 2, the total insurance premium would be available for the November budget meeting.

There is no impact on shareholders except that the new budget will commence on January 1, 2010. More information on the change to a calendar year budget will be distributed in August.

## NEW YORK STATE SENATE BILL 1706-A HAS BEEN SET ASIDE

A special notice was distributed to all shareholders with regard to a proposed change in the New York State Real Estate Property Tax Law that would increase the amount of real estate taxes being paid by commercial properties, including cooperative apartments.

There was tremendous opposition to this Bill from businesses as well as from cooperatives and condominiums throughout Westchester County. It appears passage of this Bill has been stalled.

We would like to thank those of you who wrote or emailed New York State Senator Suzi Oppenheimer. It made a difference. Hopefully the bill, originally proposed by Adam Bradley, will be withdrawn.

#### RIDGEWAY COUNTRY CLUB FOR SALE

It has been in the news that Ridgeway Country Club and golf course, which has been in existence for over 75 years, is being offered for sale.

Since the Ridgeway Country Club directly adjoins Bryant Gardens, any future sale or development of the property could have a major effect on the Bryant Gardens Community.

Ridgeway Country Club has not yet been sold, nor have any plans been submitted to the City of White Plains for development. The Board and Management will continue to monitor and follow the situation with regard to Ridgeway Country Club and provide updated information.

## DANFOSS ENERGY SAVINGS PROJECT UNDERWAY

In order to provide long term energy savings for Bryant Gardens, the Board has approved installation of Danfoss thermostatic radiator control valves in apartments as they are sold or transferred. A small number of occupied apartments will also be included. The Danfoss valves permit residents to control the temperature in their apartment during the heating season which also conserves energy. If you'd like your apartment to be considered, send a note to the Management Office.
